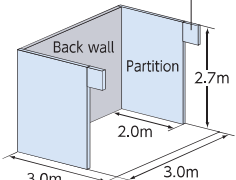

※The exhibition fee includes the online system usage fee (11,000 yen/company) and a package for attracting visitors (pamphlets and envelopes/posters to attract visitors).

Booth Configurations

▶ Basic Booth

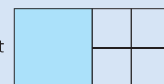
Exhibitors may freely add original decoration within their own booths at their own expense within the scope defined in the Exhibitors' Manual. However, the basic equipment (partitions, back walls, company name boards) constructed by the secretariat cannot be removed.

※If you wish to hold your display using four or six booths, you must choose either booths in a row or booths without rear walls and note your selection in the application form.

[Booths without rear walls]

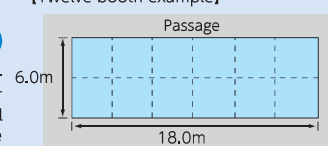


▶ Island booth (12 booths or more)

If you apply for 12 booths or more - basic booths or concrete slab floor booths - the booth configuration will be an island booth facing the aisle on all sides.

In principle, although it will be an island booth, please understand that we may not be able to comply with your request depending on the application category and all the layout of the entire venue.
